3 questions:

1. Why is the new language necessary? The draft says that, notwithstanding s. 196.49, no PSC approval is necessary. If s. 196.49 does not apply, why do we need to say that the purchase or contract nevertheless is considered to satisfy s. 196.49 (3)?
2. If you do want the new language, I don't think I'd say "deemed ... to comply with the criteria set forth in s. 196.49 (3) (b)." Based on the way that s. 196.49 (3) (b) is written, I'd say "is considered ... to comply with the criteria for certification of a project under s. 196.49 (3) (b)." (Also note that under our drafting style, we prefer "is considered" over "is deemed.")
3. The new language refers to any such purchase. Because the draft applies to purchases or contracts for operation, shouldn't the new language refer to any such purchase **or contract**?
