

Here are two additional drafts that we are requesting for the budget adjustment bill. (We ended up getting the numbers early so I figured I would send them over instead of waiting until Monday.)

\$1,779,900 From 1(f) energy costs; energy-related assessments  
\$776,000 From 1(ab) corrections contracts and agreements  
\$87,700 From 2(a) general program operations

*Transfers to 102 (1b- services for community corrections):*  
\$2,209,400 From 3(cg) serious juvenile offenders  
\$387,500 From 1(f) energy costs; energy-related assessments

*Also need funding of 37,860,000 to 101 (1a- general program operations)*

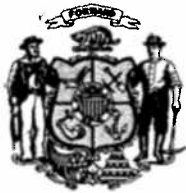



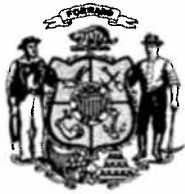
