2. Page 125, line 5: after that line insert:

"(a) The department of employee trust funds may not expend any moneys from the appropriation under section 20.515 (1) (d) of the statutes, as created by this act, for funding the cost of the study under this subsection unless the department submits a spending plan to the joint committee on finance. If the cochairpersons of the joint committee on finance do not notify the department within 14 working days after the date of the department submittal of the plan that the committee has scheduled a meeting to review the plan, the plan may be implemented and moneys may be expended as proposed by the department. If, within 14 days after the date of the department submittal of the plan, the cochairpersons of the committee notify

- the department that the committee has scheduled a meeting to review the plan,
- 2 moneys may be expended only after the plan has been approved by the committee.".
