4 2. Page 125, line 5: after that line insert:

6 "(c) The department of employee trust funds may not expend any moneys from

7 the appropriation under section 20.515 (1) (d) of the statutes, as created by this act,

8 for funding the cost of the study under this subsection unless the department

9 submits a spending plan to the joint committee on finance. If the cochairpersons of

10 the joint committee on finance do not notify the department within 14 working days

11 after the date of the department's submittal of the plan that the committee has

12 scheduled a meeting to review the plan, the plan may be implemented and moneys

13 may be expended as proposed by the department. If, within 14 days after the date

of the department's submittal of the plan, the cochairpersons of the committee notify

1 the department that the committee has scheduled a meeting to review the plan,  
2 moneys may be expended only after the plan has been approved by the committee.”.

4           **2.** Page 125, line 5: after that line insert:

5           “(cq) The department of employee trust funds may not expend any moneys from  
6 the appropriation under section 20.515 (1) (d) of the statutes, as created by this act,  
7 for funding the cost of the study under this subsection unless the department  
8 submits a spending plan to the joint committee on finance. If the cochairpersons of  
9 the joint committee on finance do not notify the department within 14 working days  
10 after the date of the department’s submittal of the plan that the committee has  
11 scheduled a meeting to review the plan, the plan may be implemented and moneys  
12 may be expended as proposed by the department. If, within 14 days after the date  
13 of the department’s submittal of the plan, the cochairpersons of the committee notify

1 the department that the committee has scheduled a meeting to review the plan,  
2 moneys may be expended only after the plan has been approved by the committee.”.
