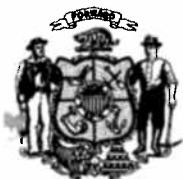

**ASSEMBLY AMENDMENT ,
TO ASSEMBLY BILL 11**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 134, line 15: after that line insert:

3 “(2m) PROHIBITING MEMBERS OF THE NATIONAL GUARD FROM SERVING AS
4 REPLACEMENT WORKERS OR LEVERAGE IN PASSING LEGISLATION. In the event of a work
5 stoppage or strike by any public employees or any labor dispute involving public
6 employees, the members of the national guard may not be used as replacement
7 workers. The members of the national guard may also not be deployed as leverage
8 for the purpose of passing legislation affecting public employees.”
