ASSEMBLY AMENDMENT,
TO ASSEMBLY BILL 11

1 At the locations indicated, amend the bill[✓] as follows:

2 1. Page 24, line 22: delete that line and substitute "credit the net proceeds, to
3 the extent that expenses are incurred, to the appropriation under s. 20.445 (1) (ga)
4 and thereafter to the budget stabilization fund".

5 2. Page 28, line 3: after that line insert:

6 "SECTION 51m[✓] 20.455 (1) (ga)[✓] of the statutes is created to read:

7 20.455 (1) (ga) *Operating while intoxicated enforcement.*[✓] All moneys credited
8 to this account under s. 16.896[✓] (3) from the sale of state-owned heating, cooling, and
9 power plants under s. 16.896[✓] to be used to provide grants to district attorneys and
10 to counties and municipalities in the amounts determined by the attorney general
11 for investigation, enforcement, and prosecution of violations of s. 343.63."
