2 **1.** Page 74, line 19: delete "PROHIBITION. A" and substitute "PROHIBITIONS. (a)

5 "(b) No labor organization representing a collective bargaining unit containing
6 a municipal employee may deduct from the earnings of the municipal employee any
7 contributions for a 3rd party".
