2 **1.** Page 74, line 19: delete "PROHIBITION. A" and substitute "PROHIBITION AND
3 UNION PAYMENT. (a) A".

4 **2.** Page 74, line 21: after that line insert:

5 "(b) A labor organization representing a collective bargaining unit containing
6 a public safety employee must pay the administrative costs of deducting from the
7 earnings of the public safety employee all labor organization dues or contributions
8 for political committees, as defined in s. 11.01 (4).".
