Replacement of Classified Positions With Unclassified Positions (p. 25)

- Require that any employee that any employee appointed to an unclassified position as a result of this legislation complete a statement of financial interest that is publicly available on the Government Accountability Board Website.
- Require Senate confirmation for any appointee to the unclassified position.
- Freeze newly created unclassified position salaries to 2009 Act 28 levels.
- Amend the bill to mandate that every position in every state department, other than secretary, is a classified civil service position.
- Make the effective date for each newly created unclassified position effective on the position becoming vacant.

Sale and Contractual Operation of State-Owned Power Plants (p. 20)

- Strike all provisions relating to state power plants
- Require any purchaser of a state power plant to sign a 25-year contract and that they must sell energy created by the power plant to consumers physically located in the state of Wisconsin Legislature
- Require the Legislative Audit Bureau to perform a study to project the 25-year costs and/or savings of the sale of any power plant.
- Allocate all revenue from the sale of power plants to the Injured Patient Compensation Fund until the fund is balanced.
- Allocate all revenue from the sale of power plants to GPR until the shortfall from the loss of MN tax reciprocity funding is balanced.
- Allocate all revenue from the sale of power plants to GPR until the shortfall for the Public Defender fund is balanced.

Repeal Collective Bargaining Rights for University System Faculty and Academic Staff (p. 45-46)

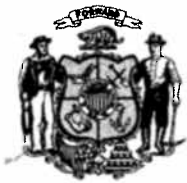

Collective Bargaining and Employment Relations Provisions (p. 38-46)

- Require the Governor to negotiate with all applicable unions on topics that are currently mandatory subjects of collective bargaining
- Require local governments to negotiate with all applicable unions on topics that are currently mandatory subjects of collective bargaining
- Draft an individual amendment for each state employee union whose bargaining rights were stripped under this bill requiring the Governor to negotiate with that union on topics that are currently mandatory subjects of collective bargaining.

4 (1m) SENATE CONFIRMATION OF UNCLASSIFIED POSITIONS. Beginning on the
5 effective date of this subsection, no person nominated for an appointment to an
6 unclassified position under section 230.08 (2) of the statutes, as affected by this act,
7 may accept the appointment unless confirmed by the senate in the manner in which
8 other appointments are confirmed by the senate."
