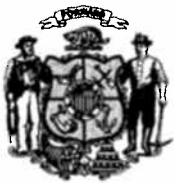

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 SECTION 9119. Nonstatutory provisions; Governor. ✓

3 (1) ✓ NEGOTIATION ON RETIREMENT AND HEALTH CARE CONTRIBUTIONS FOR
4 REPRESENTED STATE EMPLOYEES. No later than 10 ✓ days after the effective date of this
5 subsection, the governor shall commence negotiations with representatives of all
6 state employees who are included in collective bargaining units under ✓ subchapter V
7 ~~by~~ chapter 111 ✓ of the statutes over matters relating to the payment and amount of employee
8 required contributions ✓ under the Wisconsin retirement system ✓ and the payment and
9 amount of employee health insurance premiums. ✓
