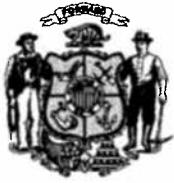

ASSEMBLY SUBSTITUTE AMENDMENT,
 TO ASSEMBLY BILL 11

1 AN ACT ~~...~~; relating to: increasing the amount of public debt that may be
 2 contracted to refund any unpaid indebtedness used to finance tax-supported
 3 or self-amortizing facilities and granting bonding authority.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 SECTION 1. 20.866 (2) (xf) of the statutes is amended to read:
 5 20.866 (2) (xf) *Building commission; refunding tax-supported and*
 6 *self-amortizing general obligation debt incurred before July 1, 2011.* From the
 7 capital improvement fund, a sum sufficient to refund the whole or any part of any
 8 unpaid indebtedness used to finance tax-supported or self-amortizing facilities.
 9 The state may contract public debt in an amount not to exceed \$309,000,000
 10 \$474,000,000 for this purpose. Such indebtedness shall be construed to include any
 11 premium and interest payable with respect thereto. Debt incurred by this paragraph

1 shall be incurred before July 1, 2011, and shall be repaid under the appropriations
2 providing for the retirement of public debt incurred for tax-supported and
3 self-amortizing facilities in proportional amounts to the purposes for which the debt
4 was refinanced.
