Below are a list of amendments that we'd like drafted for the sub, whenever that becomes available.

- 1) Delete the county highway contract provision, this is from JFC Motion 352, Item 26
 - 2) ~~Delete changes to septic system rules, this is from JFC Motion 518, Item 24~~
 - 3) Remove the exemption of solid waste disposed at solid waste disposal facility, this was from finance motion 440, Item 8.
 - 4) Restore \$234 million cut to Stewardship (Motion 265)
 - 5) Remove JFC Review over Stewardship purchasing (Motion 265)
 - 6) Require public reporting of unscheduled discharges of wastewater (Motion 295)
 - 7) Delete increase to the percentage of market rate from 80% to 80% for CWFP (clean water fund protection) loans. (paper 300)
 - 8) Restore PACE fully (Paper 136)
 - 9) Fully fund Recycling at \$32 Million per year (Motion #440, Item 3)
 - 10) Up the allocation for the Freight Rail Preservation Program from \$30 Million to \$60 Million
 - 11) Farm to School. We'd like have an amendment to include the language from JFC Motion #237
 - 12) Honor PACE Grants beyond the 16 approved farms and keep the 32 who are preapproved in the program (DATCP Omnibus)
 - 13) Restore runoff Rules. Motion #440, Item 9
 - 14) Move the position that monitors construction site erosion back to DNR
 - 15) Restore the Brownfields/Toxic Waste Clean Up grants (Motion #440, item 7)
 - 16) Send the Vehicle Environmental Impact Fee to DNR for contaminated land cleanups caused by vehicles and petroleum projects. Motion #440 item 4 LFB paper #498

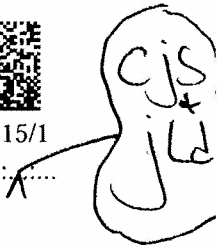

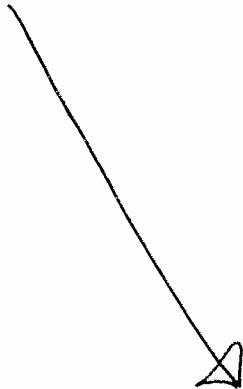
