Attached is an amendment we'd like drafted to Sub 1 to AB 40. Please call if you have any questions, hope it's not too vague.

Restoration of the Social Safety Net

- ✓ Eliminate authority of DHS Secretary to make unilateral changes to non-statutory provisions of BadgerCare, BadgerCare Plus, FamilyCare and SeniorCare without legislative approval. Require him/her to submit a plan to JFC under 14 day passive review. Require that savings must be found in administrative efficiencies and may not come from benefits to individuals *benefits/*
- ✓ Eliminate authority of DCF Secretary to implement cost savings measures to the WisconsinShares program without legislative approval. Require her/him to submit a plan to JFC under 14 day passive review. Require that savings must be found in administrative efficiencies and may not come from benefits to individuals

- ✓ Eliminate changes to W2 program
- ✓ Eliminate requirement that individuals must wait 1 week before applying for UI benefits
- ✓ Eliminate all changes to EITC and Homestead programs
- ✓ Eliminate all changes to child labor laws
- ✓ Restore full GPR funding to child support enforcement agencies and eliminate the new funding distribution method passed by JFC
