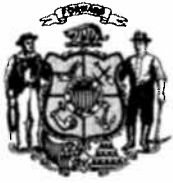

TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2011 ASSEMBLY BILL 40**

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 1456, line 20: after that line insert:

3 **(13A)** MEDICARE VOUCHERS. Under section 165.25 (1m) of the statutes, the
4 legislature authorizes the attorney general to file or join a lawsuit on behalf of the
5 state or the people of this state challenging a voucher system for the federal Medicare
6 program, if the federal government implements a voucher approach to the Medicare
7 program.”.
