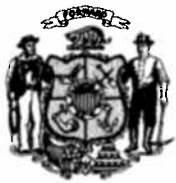

Page 1451, line 1: delete that line and substitute:

- (A) (c) ^(A) Exceptions to the enrollment cap.
- (A) 1. ^(A) Relocation from institutional facility. ^(A)

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 1451, line 1: delete "Exception" and substitute "Exceptions".

3 **2.** Page 1451, line 1: after "cap." insert "1. Relocation from institutional
4 facility."

5 **3.** Page 1451, line 4: delete "1." and substitute "a."

6 **4.** Page 1451, line 5: delete "2." and substitute "b."

7 **5.** Page 1451, line 7: delete "3." and substitute "c."

8 **6.** Page 1451, line 9: delete "4." and substitute "d."

9 **7.** Page 1451, line 10: delete "5." and substitute "e."

10 **8.** Page 1451, line 11: after that line insert:

1 “2. ‘County with a population of 750,000 or more.’ The enrollment cap under
 2 paragraph (b) does not apply to a county with a population of 750,000 or more. For
 3 purposes of paragraph (b), the number of individuals enrolled in long-term care
 4 programs in a resource center service area does not include individuals enrolled in
 5 long-term care programs ~~that~~^{who} reside in a county with a population of 750,000.”. ✓
