ASSEMBLY AMENDMENT 35, TO ASSEMBLY SUBSTITUTE AMENDMENT 1, TO 2011 ASSEMBLY BILL 40

June 14, 2011 – Offered by Representatives Barca, Roys, Seidel, Berceau, Bewley, Hebl, Pocan, Ringhand, Pasch, Toles, Jorgensen, Hulsey, E. Coggs, Mason, Danou, Young, Milroy and Turner.

- 11 71.27 **(2)** The corporation franchise tax imposed under s. 71.23 (2) and measured by Wisconsin net income shall be computed at the rate of 7.9% 7.9 percent, except that the rate is 7.6 percent for taxable years beginning on or after January 1, 2012.".
