



**SENATE AMENDMENT 7,
TO 2011 ASSEMBLY BILL 40**

June 16, 2011 – Offered by Senators RISSER, MILLER, C. LARSON, CARPENTER, S. COGGS, T. CULLEN, ERPENBACH, HANSEN, HOLPERIN, JAUCH, LASSA, TAYLOR, VINEHOUT and WIRCH.

1 At the locations indicated, amend the bill, as shown by assembly substitute
2 amendment 1, as follows:

3 **1.** Page 30, line 22: delete “, ~~the office of energy independence in the~~
4 ~~department of~~” and substitute “, the office of energy independence in the department
5 of”.

6 **2.** Page 30, line 23: delete “~~administration, the~~” and substitute
7 “administration, the”.

8 **3.** Page 33, line 15: delete that line.

9 **4.** Page 52, line 9: delete that line.

10 **5.** Page 53, line 22: delete that line.

11 **6.** Page 76, line 16: delete lines 16 to 24.

1 **7.** Page 162, line 14: increase the dollar amount for fiscal year 2011–12 by
2 \$13,000,000 and increase the dollar amount for fiscal year 2012–13 by \$13,000,000
3 to increase funding for the purpose for which the appropriation is made.

4 **8.** Page 377, line 16: delete the material beginning with that line and ending
5 with page 378, line 3.

6 **9.** Page 395, line 22: delete the material beginning with that line and ending
7 with page 396, line 21.

8 **10.** Page 399, line 12: delete the material beginning with that line and ending
9 with page 401, line 16.

10 **11.** Page 405, line 23: delete lines 23 to 25.

11 **12.** Page 407, line 19: delete the material beginning with that line and ending
12 with page 408, line 4.

13 **13.** Page 931, line 21: delete lines 21 to 25.

14 **14.** Page 933, line 20: delete lines 20 to 23.

15 **15.** Page 935, line 1: delete that line and substitute “services, the department
16 of revenue, and the office of energy independence, shall”.

17 **16.** Page 935, line 6: delete that line and substitute “safety and professional
18 services, the department of revenue, and the office of”.

19 **17.** Page 935, line 7: delete “energy independence” and substitute “energy
20 independence”.

21 **18.** Page 935, line 11: delete that line and substitute:
22 “services, the department of revenue, or the office of energy independence to”.

23 **19.** Page 1405, line 21: after that line insert:

1 “(6i) OFFICE OF ENERGY INDEPENDENCE; POSITION AUTHORIZATIONS. The authorized
2 FTE positions for the department of administration, funded from the appropriation
3 under section 20.505 (1) (mb) of the statutes, are increased by 2.0 FED positions for
4 the performance of services for the office of energy independence.”.
