**SENATE AMENDMENT ,**  
**TO SENATE SUBSTITUTE AMENDMENT 1,**  
**TO SENATE BILL 2**

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 2, line 9: delete "The following" and substitute "Except as otherwise  
3 provided, the following".

4 **2.** Page 2, line 13: delete "accounts." and substitute "accounts, except that  
5 these provisions may not take effect until the cochairs of the joint committee on  
6 finance specify spending cuts to the state budget that will equal the costs incurred  
7 by the state, as determined by the department of revenue, due to the adoption of  
8 these provisions."

9 **3.** Page 2, line 16: after that line insert:

10 *create*  
*a.* *persons*  
"2) COCHAIRS TO SPECIFY SPENDING CUTS. Not later than 5 working days after  
11 the governor signs this act, the cochairs *persons* of the joint committee on finance shall

1 introduce, in their respective houses of the legislature, a bill that specifies the  
2 spending cuts described in section 71.98 (1) of the statutes.

3 (3) LEGISLATIVE ACTION.

4 *check*  
*appeal* (a) Not later than 10 working days after the introduction of the bills described  
5 in subsection (2), both houses of the legislature shall hold public hearings on the bills.

6 (b) Not later than 5 working days after the conclusion of the hearings required  
7 under paragraph (a), each house of the legislature shall take executive action on the  
8 bills.”
