2 √1. Page 27, line 10: delete "or criminal".

3 √2. Page 27, line 18: after that line insert:

4 "(4) This section does not preclude the discovery in a civil or criminal action  
5 brought against a health care provider of reports, statements, and records described  
6 in sub. (2) that are provided to the division within the department of health services  
7 that conducts quality assurance activities related to health care providers."
