


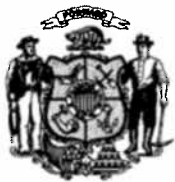

1. Page ³2, line ¹⁷20: after that line insert:

“(m) If a person who is eligible to receive the credit under this subsection

return, a form prepared by the department and shall submit to the department any
