5 "SECTION 1. <sup>e</sup> 560.01 (2) (ae) 7. <sup>(intro.)</sup> of the statutes is amended to read:

6 560.01 (2) (ae) 7. <sup>(intro.)</sup> Establish by rule policies and procedures requiring the  
 7 department to recoup payments made to a recipient of a grant or loan or tax benefits  
 8 under the program, and permitting the department to do all of the following, if such  
 9 a recipient of a grant or loan or tax benefits under the program submits false or  
 10 misleading information to the department or fails to comply with the terms of a  
 11 contract entered into with the department under the program and fails to provide to  
 12 the satisfaction of the department an explanation for the noncompliance:

- 1 a. ~~Recoup payments made to the recipient.~~
- 2 b. Withhold payments to be made to the recipient.
- 3 c. ~~Impose a forfeiture on the recipient.~~
