ASSEMBLY AMENDMENT *fe*,
TO ASSEMBLY BILL 4

January 12, 2011 - Offered by Representatives MOLEPSKE JR and BERNARD SCHAPER.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 2: after "program" insert "and modifying certain accountability
3 measures for economic development programs".

4 **2.** Page 1, line 3: before that line insert:

5 "SECTION 1e. 560.01 (2) (ae) 7. (intro.) of the statutes is amended to read:

6 560.01 (2) (ae) 7. (intro.) Establish by rule policies and procedures requiring
7 the department to recoup payments made to a recipient of a grant or loan or tax
8 benefits under the program, and permitting the department to do all of the following.
9 if such a recipient of a grant or loan or tax benefits under the program submits false
10 or misleading information to the department or fails to comply with the terms of a
11 contract entered into with the department under the program and fails to provide to
12 the satisfaction of the department an explanation for the noncompliance:

13 **SECTION 1m.** 560.01 (2) (ae) 7. a. of the statutes is repealed."
