1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 4: after that line insert:

3 "SECTION 1d. 560.706 (4) of the statutes is created to read:

4 560.706 (4) AUDITS. The department shall annually contract with the
5 legislative audit bureau to conduct financial and performance audits of the program

6 under ss. 560.701 to 560.705 and the completed audits shall be submitted to the joint
7 legislative audit committee and to the appropriate standing committees of the
8 legislature as provided under s. 13.172 (3).".
