7 560.703 (1) (am) If the department does not allocate the additional \$25,000,000[✓]
8 in tax benefits specified in par. (a)[✓] before July 1, 2012,[✓] the department may not
9 allocate the additional \$25,000,000[✓] in tax benefits specified in par. (a)[✓] and the
10 department shall notify the department of administration on July 1, 2012,[✓] that such
11 tax benefits shall not be allocated."[✓]
