

**SENATE AMENDMENT ,
TO SENATE SUBSTITUTE AMENDMENT 1,
TO SENATE BILL 6**

1 At the locations indicated, amend the substitute amendment[✓] as follows:
2 **1.** Page 25, line 20:[✓] after that line insert:
3 “(3) NOTICE REQUIRED.[✓] If the abolition of a position under subsection (1)[✓] will
4 result in the termination of a current economic development program of the
5 department of commerce, or if a transfer under subsection (2)[✓] will eliminate all
6 funding for a current economic development program of the department of
7 commerce, the secretary may not abolish the positions or make the transfer,
8 respectively, unless the secretary has provided not less than 15 days written notice
9 to any person that will lose funding, or an opportunity to receive funding for which

1 the person is negotiating with the department of commerce, as a result of the
2 abolition or transfer.”.
