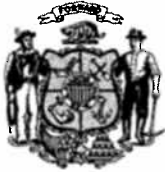

3 modifying general school aids, general transportation aids, and shared revenue  
4 payments". *INSERT A*

5 **2.** Page 1, line 4: after "rates" insert *or decreasing or modifying general*  
6 **school aids, general transportation aids, or shared revenue payments**". *INSERT B*

7 **3.** Page 1, line 6: after "franchise tax" insert "or that decreases general school  
8 aids, general transportation aids, or shared revenue payments from the amount  
9 appropriated in the prior fiscal year or that modifies the distribution of general  
10 school aids, general transportation aids, or shared revenue payments". *INSERT C*

11 **4.** Page 2, line 3: after "increase" insert "or decrease in, or modification of,  
12 general school aids, general transportation aids, or shared revenue payments".
