Gordon,

For the technical amendment to ASA 1 to SS AB 8, in addition the two items I brought to your attention over the phone, here is an additional technical change:

- Pg 16, lines 6-7: remove the following language: "or filed with the legislative reference bureau under s. 227.20 for publication under s. 227.21". [Some have argued that this language creates a third approval by the governor immediately before publication. I don't believe this is intended. Removing it will avoid any confusion.]

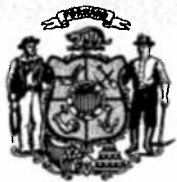
Hi Gordon, various parties asked me to review LRB 0034/1 and in doing so I came up with the following technical notes. I am sharing them with you for your information.

- On page 18, line 6, the word "committee" should be replaced with "committees" and the text "requesting the modifications" should be removed. (This is because the agency has to contact both standing committees in this scenario otherwise there is no entity obligated to inform the committee that did not request the modifications when its 10-day review has started.)
- The changes made in lines 20-22 on page 19 need to be removed. (Gordon, Jessica told me that you two might have come up with an alternative means of dealing with this)
- On page 22, line 10, "committee review" should be replaced with "review by the joint committee for review of administrative rules"
- On page 24, line 9, add "its jurisdiction" after "waive"
