1 At the locations indicated, amend the substitute amendment as follows:

2 ↓ 1. Page 9, line 14: after “statement” insert “, unless either house of the
3 legislature, within 30 days after the statement is presented to the governor, passes
4 a resolution requesting the agency to send the statement to the legislative reference
5 bureau for publication under sub. (3)”.

6 ↓ 2. Page 9, line 25: after “statement” insert “or, if the governor does not approve
7 the statement, until that individual or body approves the statement and a house of
8 the legislature passes the resolution specified in this subsection”.

9 ↓ 3. Page 10, line 3: after “(2)” insert “or if the individual or body with
10 policy-making powers over the subject matter of the proposed rule approves the
11 statement and a house of the legislature passes the resolution specified in sub. (2)”.

1 ↓ **4.** Page 16, line 8: after “writing” insert “or, if the governor does not approve
2 the proposed rule in writing, either house of the legislature, within 30 days after the
3 proposed rule is submitted to the governor, passes a resolution requesting the agency
4 to submit the proposed rule to the legislature for review under s. 227.19 (2) or to file
5 the proposed rule with the legislative reference bureau under s. 227.20 for
6 publication under s. 227.21”.
