~~1. Page 9, line 14: after "statement" insert ". unless either house of the legislature, within 30 days after the statement is presented to the governor, passes a resolution requesting the agency to send the statement to the legislative reference bureau for publication under sub. (3)".~~

~~2. Page 9, line 25: after "statement" insert "or, if the governor does not approve the statement, until that individual or body approves the statement and a house of the legislature passes the resolution specified in this subsection".~~

~~3. Page 10, line 3: after "(2)," insert "or if the individual or body with policy-making powers over the subject matter of the proposed rule approves the statement and a house of the legislature passes the resolution specified in sub. (2)."~~
