ASSEMBLY AMENDMENT 18, TO ASSEMBLY SUBSTITUTE AMENDMENT 1, TO ASSEMBLY BILL 8

February 2, 2011 – Offered by Representatives HEBL and STASKUNAS.

1	At the locations indicated, amend the substitute amendment as follows:
2	1. Page 9, line 7: after " <u>agency</u> " insert " <u>, other than the office of the state</u>
3	treasurer, the office of the secretary of state, the department of justice, or the
4	department of public instruction.".
5	2. Page 9, line 22: after " <u>rule</u> " insert " <u>to which this subsection applies</u> ".
6	3. Page 9, line 25: after that line insert:
7	"SECTION 4m. 227.135 (2m) of the statutes is created to read:
8	227.135 (2m) If an agency that is the office of the state treasurer, the office of
9	the secretary of state, the department of justice, or the department of public
10	instruction prepares a statement of the scope of a proposed rule, that agency shall
11	present the statement to the individual or body with policy–making powers over the
12	subject matter of the proposed rule for approval. The individual or body with

1 policy–making powers may not approve the statement until at least 10 days after 2 publication of the statement under sub. (3). No state employee or official may 3 perform any activity in connection with the drafting of a proposed rule except for an 4 activity necessary to prepare the statement of the scope of the proposed rule until the 5 individual or body with policy-making powers over the subject matter of the proposed rule approves the statement.". 6 **4.** Page 10, line 3: after "(2)" insert "or if the individual or body with 7 8 policy-making powers over the subject matter of the proposed rule approves a 9 statement of the scope of the proposed rule under sub. (2m)". 10 **5.** Page 10, line 9: after "(2)" insert "or (2m)". 11 **6.** Page 16, line 1: after "rule" insert "that has been drafted by an agency other 12 than the office of the state treasurer, the office of the secretary of state, the 13 department of justice, or the department of public instruction". 14 **7.** Page 16, line 5: after "rule" insert "that has been drafted by such an agency". 15 **8.** Page 24, line 11: after "a proposed rule" insert "that has been drafted by an 16 agency other than the office of the state treasurer, the office of the secretary of state, 17 the department of justice, or the department of public instruction". 18 **9.** Page 24, line 18: after "<u>objection</u>" insert "<u>or if the proposed rule or part of</u> 19 the proposed rule is not reported to the governor". **10.** Page 26, line 14: after "(2)" insert "or (2m)". 20 21 **11.** Page 27, line 2: after "writing." insert "This subdivision does not apply to 22 a proposed emergency rule drafted by the office of the state treasurer, the office of the 4

- secretary of state, the department of justice, or the department of public
 instruction.".
