Page 9, line 14: after "statement" insert ". except that, if the governor does not disapprove the statement within 30 days after the statement is presented to the governor, the statement is considered to be approved and the agency may send the statement to the legislative reference bureau for publication under sub. (3)".

2. Page 16, line 8: after "writing" insert ", except that, if the governor does not reject the proposed rule within 30 days after the proposed rule is submitted to the governor, the proposed rule is considered to be approved and the agency may submit the proposed rule to the legislature for review under s. 227.19 (2)".

3. Page 27, line 2: after "writing" insert ", except that, if the governor does not reject the proposed emergency rule within 30 days after the proposed emergency rule

1 is submitted to the governor, the proposed emergency rule is considered to be
2 approved and the agency may file the emergency rule for publication". ✓
