**SENATE AMENDMENT 11,
TO ASSEMBLY BILL 8**

February 10, 2011 – Offered by Senators JAUCH, HANSEN, LASSA, MILLER, RISSER,
CARPENTER, T. CULLEN, C. LARSON, HOLPERIN, VINEHOUT and TAYLOR.

1 At the locations indicated, amend the bill, as shown by assembly substitute
2 amendment 1, as follows:

3 **1.** Page 9, line 7: delete “An” and substitute “Except as provided in sub. (2m),
4 an”.

5 **2.** Page 9, line 22: after “rule” insert “to which this subsection applies”.

6 **3.** Page 9, line 25: after that line insert:

7 “**SECTION 4g.** 227.135 (2m) of the statutes is created to read:

8 227.135 (**2m**) If the the government accountability board prepares a statement
9 of the scope of a proposed rule, that board shall present the statement to the
10 individual or body with policy-making powers over the subject matter of the
11 proposed rule for approval. The individual or body with policy-making powers may
12 not approve the statement until at least 10 days after publication of the statement
13 under sub. (3). No state employee or official may perform any activity in connection

1 with the drafting of a proposed rule to which this subsection applies except for an
2 activity necessary to prepare the statement of the scope of the proposed rule until the
3 individual or body with policy-making powers approves the statement.”.

4 **4.** Page 10, line 4: after “register.” insert “If a statement of the scope of a
5 proposed rule is presented to the individual or body with policy-making powers over
6 the subject matter of the proposed rule under sub. (2m), the government
7 accountability board presenting the statement shall send the statement to the
8 legislative reference bureau for publication in the register.”.

9 **5.** Page 10, line 9: after “(2)” insert “or (2m)”.

10 **6.** Page 10, line 15: after “(2)” insert “or under subs. (1) and (2m)”.

11 **7.** Page 16, line 1: delete “After” and substitute “Except as provided in this
12 section, after”.

13 **8.** Page 16, line 8: after “writing.” insert “This section does not apply to a
14 proposed rule drafted by the government accountability board.”.

15 **9.** Page 26, line 14: after “(2)” insert “or (2m),”.

16 **10.** Page 26, line 21: delete “Submit” and substitute “Except as provided in
17 this subdivision, submit”.

18 **11.** Page 27, line 2: after “writing.” insert “This subdivision does not apply to
19 a proposed emergency rule drafted by the government accountability board.”.

20 **12.** Page 28, line 22: delete “GUBERNATORIAL” and substitute “ADMINISTRATIVE”.

21 **13.** Page 28, line 23: after “(2),” insert “(2m),”.
