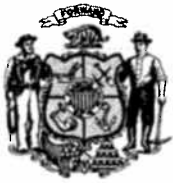

15 **6.** Page 10, line 15: after “(2)” insert “or under subs. (1) and (2m)”.

16 **7.** Page 16, line 1: delete “After” and substitute “Except as provided in this
17 section, after”.

18 **8.** Page 16, line 8: after “writing.” insert “This section does not apply to a
