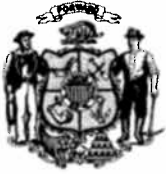

3 “(6) APPLICATION. The intrastate switched access rate reductions required by  
 4 this section apply to any entity subject to those rates, regardless of the technology  
 5 or mode used by that entity to provide its telecommunications services.” ✓
