## **SENATE AMENDMENT 5,**

## **TO SENATE BILL 13**

May 11, 2011 – Offered by Senators Erpenbach, Taylor, Vinehout, C. Larson, Carpenter, Risser and Miller.

1 At the locations indicated, amend the bill as follows: **1.** Page 18, line 16: delete "Except as provided in subd. 2., a" and substitute 2 "A". 3 **2.** Page 18, line 18: after "commission" insert ", except as provided in subd. 2. 4 a., and except that the commission may modify the proposed change after an 5 6 opportunity for a hearing if the commission finds that the proposed change violates 7 a provision of this chapter that applies to the telecommunications utility or 8 alternative telecommunications utility". 9 **3.** Page 19, line 20: delete lines 20 to 22 and substitute "only to the extent that the tariff violates a provision of this chapter that applies to the telecommunications 10 11 utility or alternative telecommunications utility.". **4.** Page 20, line 23: delete the material beginning with that line and ending 12 with page 21, line 2. 13
