6 **5.** Page 48, line 3: delete "The commission" and substitute "Except as provided  
7 in par. (e), the commission". ✓

8 **6.** Page 48, line 13: after "satisfied" insert "and whether par. (e) prohibits  
9 granting the waiver". ✓

10 **7.** Page 48, line 18: after "law" insert "unless the commission determines that  
11 par. (e) prohibits granting the waiver". ✓

1           **8.** Page 48, line 19: delete "The commission" and substitute "Unless the  
2           commission determines that par. (e) prohibits granting a waiver, the commission". ✓

3           **9.** Page 48, line 23: after "law" insert "unless the commission determines that  
4           par. (e) prohibits granting the waiver". ✓

5           **10.** Page 48, line 25: after that line insert:

6           "(e) The commission may not grant a waiver under this subsection if customers  
7           in the affected service territory would not have access to basic voice service if the  
8           waiver were granted." ✓
