1 At the locations indicated, amend the bill as follows:

2 1. Page 32, line 7: after "196.01" insert "(3a)".

3 2. Page 32, line 21: delete the material beginning with that line and ending
4 with page 33, line 9, and substitute:

5 "(3) SWITCHED ACCESS RATES. Nothing in this section shall be construed to
6 require or prohibit the payment of switched access rates or other intercarrier
7 compensation."
