15 include a machine gun, as defined in s. 941.27 (1), a short-barreled rifle, as defined
16 in s. 941.28 (1) (b), or a short-barreled shotgun, as defined in s. 941.28 (1) (c).

17 (bv) “Law enforcement agency” does not include the department.

18 (c) “Law enforcement officer” has the meaning given in s. 165.85 (2) (c).

19 (d) “Licensee” means an individual holding a valid optional license issued
20 under this section to carry a concealed weapon.

21 (f) “Out-of-state license” means a valid permit, license, approval, or other
22 authorization issued by another state if all of the following apply:

23 1. The permit, license, approval, or other authorization is for the carrying of a
24 concealed weapon.

1 2. The state is listed in the rule promulgated by the department under s. 165.25
2 (12) and, if that state does not require a background search for the permit, license,
3 approval, or authorization, the permit, license, approval, or authorization
4 designates that the holder chose to submit to a background search.

5 (g) “Out-of-state licensee” means an individual who is 21 years of age or over,
6 who is not a Wisconsin resident, and who has been issued an out-of-state license.

7 (i) “State identification card number” means the unique identifying driver
8 number assigned to a person by the department of transportation under s. 343.17 (3)
9 (a) 4. or, if the person has no driver number, the number assigned to the person on
10 an identification card issued under s. 343.50.

11 (j) “Weapon” means a handgun, an electric weapon, as defined in s. 939.222
12 (11m), a knife other than a switchblade knife under s. 941.24, or a billy club.

13 **(2) ISSUANCE AND SCOPE OF LICENSE.** (a) The department shall issue an optional
14 license to carry a concealed weapon to any individual who is not disqualified under
15 sub. (3) and who completes the application process specified in sub. (7). An optional
16 license to carry a concealed weapon issued under this section shall meet the
17 requirements specified in sub. (2m).

18 (b) The department may not impose conditions, limitations, or requirements
19 that are not expressly provided for in this section on the issuance, scope, effect, or
20 content of a license.

21 (c) This section does not limit an individual’s right to carry a firearm that is not
22 concealed. Except as provided in s. 948.605 (2) (b) 1r., the optional license issued
23 under this section conveys no additional rights under Wisconsin state law to carry
24 a firearm that is concealed than an individual who does not have a license issued
25 under this section has to carry a firearm that is concealed.

1 (d) For purposes of 18 USC 922 (q) (2) (B) (ii), an out-of-state licensee is
2 licensed by the state.

3 **(2m)** LICENSE DOCUMENT; CONTENT OF LICENSE. (a) Subject to pars. (b), (bm), (c),
4 and (d), the department shall design a single license document for licenses issued and
5 renewed under this section. The department shall complete the design of the license
6 document no later than the first day of the 2nd month beginning after the effective
7 date of this paragraph [LRB inserts date].

8 (b) A license document for a license issued under this section shall contain all
9 of the following on one side:

10 1. The full name, date of birth, and residence address of the licensee.

11 2. A physical description of the licensee, including sex, height, hair color, and
12 eye color.

13 3. The date on which the license was issued.

14 4. The date on which the license expires.

15 5. The name of this state.

16 6. A unique identification number for each licensee.

17 (bm) The reverse side of a license document issued under this section shall
18 notify the licensee that he or she shall inform the department of any address change.

19 (c) The license document may not contain the licensee's social security number.

20 (d) 1. The contents of the license document shall be included in the document
21 in substantially the same way that the contents of an operator's license document
22 issued under s. 343.17 are included in that document.

23 2. The license document issued under this section shall be tamper proof in
24 substantially the same way that the operator's license is tamper proof under s.
25 343.17 (2).

1 (e) The department of justice may contract with the department of
2 transportation to produce and issue license documents under this section. Neither
3 the department of transportation nor any employee of the department of
4 transportation may store, maintain, or access the information provided by the
5 department of justice for the production or issuance of license documents other than
6 to the extent necessary to produce or issue the license documents.

7 **(3) RESTRICTIONS ON ISSUING A LICENSE.** The department shall issue an optional
8 license under this section to an individual who submits an application under sub. (7)
9 unless any of the following applies:

10 (a) The individual is less than 21 years of age.

11 (b) The individual is prohibited under federal law from possessing a firearm
12 that has been transported in interstate or foreign commerce.

13 (c) The individual is prohibited from possessing a firearm under s. 941.29.

14 (d) The individual is not a Wisconsin resident.

15 **(5) APPLICATION AND RENEWAL FORMS.** (a) The department shall design an
16 application form for use by individuals who apply for an optional license under this
17 section and a renewal form for use by individuals applying for renewal of an optional
18 license under sub. (15). The department shall complete the design of the application
19 form no later than the first day of the 2nd month beginning after the effective date
20 of this paragraph [LRB inserts date], and shall complete the design of the renewal
21 form no later than the first day of the 36th month beginning after the effective date
22 of this paragraph [LRB inserts date]. The forms shall require the applicant to
23 provide only his or her name, address, date of birth, state identification card number,
24 race, sex, height, hair color, and eye color and shall include all of the following:

1 1. A statement that the applicant is ineligible for a license if sub. (3) (a), (b), (c),
2 or (d) applies to the applicant.

3 2. A statement explaining self–defense and defense of others under s. 939.48,
4 with a place for the applicant to sign his or her name to indicate that he or she has
5 read and understands the statement.

6 3. A statement, with a place for the applicant to sign his or her name, to indicate
7 that the applicant has read and understands the requirements of this section.

8 4. A statement that an applicant may be prosecuted if he or she intentionally
9 gives a false answer to any question on the application or intentionally submits a
10 falsified document with the application.

11 5. A statement of the penalties for intentionally giving a false answer to any
12 question on the application or intentionally submitting a falsified document with the
13 application.

14 6. A statement of the places under ss. 941.232 (2) and 948.605 (2) (b) where a
15 licensee is prohibited from carrying a weapon, as well as an explanation of the
16 provisions under ss. 941.232 (3) and 943.13 (1m) (c) that could limit the places where
17 the licensee may carry a weapon, with a place for the applicant to sign his or her name
18 to indicate that he or she has read and understands the statement.

19 (b) The department shall make the forms described in this subsection available
20 on the Internet and, upon request, by mail.

21 **(7) SUBMISSION OF APPLICATION.** An individual may apply for an optional license
22 under this section with the department by submitting, by mail or other means made
23 available by the department, to the department all of the following:

24 (a) A completed application in the form prescribed under sub. (5) (a).

1 (b) A statement that states that the information that he or she is providing in
2 the application submitted under par. (a) and any document submitted with the
3 application is true and complete to the best of his or her knowledge.

4 (c) A license fee in an amount, as determined by the department by rule, that
5 is equal to the cost of issuing the license but does not exceed \$52. The department

9 **(9)** PROCESSING OF APPLICATION. (a) Upon receiving an application submitted
10 under sub. (7), the department shall conduct a background check.

11 (b) Within 21 days after receiving a complete application under sub. (7), the
12 department shall do one of the following:

13 1. Issue the license and promptly send the licensee his or her license document
14 by 1st class mail.

15 2. Deny the application, but only if sub. (3) (a), (b), (c), or (d) applies to the
