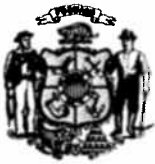

- 3 or remains in a residence that is not a single-family residence and that the actor does
- 4 not occupy if the owner of the residence has notified the actor not to enter or remain
- 5 at the residence while carrying a firearm".
- 6 ↓ 2. Page 31, line 13: delete "does not include" and substitute "includes".
- 7 ↓ 3. Page 31, line 14: delete "located or" and substitute "located and".
- 8 ↓ 4. Page 33, line 1: before that line insert:
- 9 "1m. For the purposes of sub. (1m) (c) 1., an owner of a residence has notified
- 10 an individual not to enter or remain in a residence while carrying a firearm if the
- 11 owner has posted a sign that is located in a prominent place near all of the entrances

1           At the locations indicated, amend the substitute amendment as follows:

2           **1.** Page 31, line 9: after “firearm” insert “, or, while carrying a firearm, enters  
3 or remains in a residence that is not a single-family residence and that the actor does  
4 not occupy if the owner of the residence has notified the actor not to enter or remain  
5 at the residence while carrying a firearm”.

6           **2.** Page 31, line 13: delete “does not include” and substitute “includes”.

7           **3.** Page 31, line 14: delete “located or” and substitute “located and”.

8           **4.** Page 33, line 1: before that line insert:

9           “1m. For the purposes of sub. (1m) (c) 1., an owner of a residence has notified  
10 an individual not to enter or remain in a residence while carrying a firearm if the  
11 owner has posted a sign that is located in a prominent place near all of the entrances

1 to the residence to which the restriction applies and any individual entering the
