1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 30, line 2: after “employment” insert “, including any period that the

4 **2.** Page 30, line 7: delete “or whether” and substitute “, except that an
5 employer may prohibit an employee from carrying or storing any weapon or
6 ammunition in the employee’s own vehicle if”.
