

Amendment to SSA ____ (LRB0135/3) to SB 93

Motion:

Move to amend the bill as follows:

1. Change the program revenue continuing appropriation for background checks for licenses in the Department of Justice to a program revenue annual appropriation.
2. Provide \$62,300 PR annually, beginning in 2011-12 for 1.0 permanent PR position.
3. Provide \$174,400 PR for 10.0 limited-term employees for a six-month period in 2011-12.
4. Provide \$77,100 PR for supplies and services in 2011-12.
