1 At the locations indicated, amend the substitute amendment<sup>✓</sup> as follows:

2 1. Page<sup>✓</sup> 53, line 9: after that line insert:

3 "4m.<sup>✓</sup> Enters or remains in any part of a building or grounds<sup>✓</sup> of a public zoo if  
4 the state or local governmental unit<sup>✓</sup> that operates the zoo or of a private zoo if the  
5 person who operates the zoo has notified the actor not to enter or remain in the  
6 building or on the grounds while carrying a firearm or with that type of firearm."<sup>✓</sup>

7 2. Page 55, line 7:<sup>✓</sup> after that line insert:

8 "bm.<sup>✓</sup> For the purposes of sub. (1m) (c) 4m.,<sup>✓</sup> the state, local governmental unit,  
9 or person<sup>✓</sup> has notified an individual not to enter or remain in the building or on the  
10 grounds while carrying a firearm or with a particular type of firearm if the state, local  
11 governmental unit,<sup>✓</sup> or person has posted a sign that is located in a prominent place

1 near all of the entrances to the building or the grounds to which the restriction  
2 applies and any individual entering the building or the grounds attending the special  
3 event can be reasonably expected to see the sign.” ✓
