Hi Mary,

We have now received the Substitute Amendment to AB 96. Rep. Milroy would like three amendments, each drafted separately.

- 1) The bill would not take effect until the next gubernatorial election *regular election only*
- 2) The Appt of the Secretary would require a 2/3 vote of the Senate for confirmation
- 3) On page 1, lines 7-9, amend it to require that the governor shall personally consult with the County Veterans Service Officers Association of Wisconsin AND with the presiding officers of at least 6 additional Wisconsin veterans organizations.

The Exec Session of the committee is scheduled on Thursday, May 12, at 10:00 am.

15.05 (1) (a) 2. The secretary of veterans affairs shall be nominated by the governor, and with the advice and consent of two-thirds of the senate present and voting, shall be appointed to serve at the pleasure of the governor.”

2. Page 1, line 6: substitute “(1m)” for “(1)”.

3. Page 1, line 9: after “with” insert “a county veterans service officer from each county in the state and with”.

4. Page 3, line 16: after that line insert:

“(2m) Notwithstanding section 15.49 (2) of the statutes, as affected by this act, any person serving as a member of the board of veterans affairs on the effective date of this subsection whose nomination has been confirmed by the senate on or before that date may continue to hold office and exercise the powers and duties of that office for the residue of his or her unexpired term, as determined under SECTION 10(5), and until his or her successor is appointed and qualified.”

Page 4, line 3: delete “(a)”.

5. Page 4, line 4: delete lines 4 to 20 and substitute

(?) “stats., and section 15.49 (2) of the statutes, as affected by this act, the 2 members of the board of veterans affairs who are serving on the board on the effective date of this act and whose terms expire on May 1, 2019, shall serve for terms expiring on May 1, 2017.”

6. Page 4, line 20: after that line insert:

SECTION 10. Effective date.

This act takes effect on February 1, 2015.”
