ASSEMBLY AMENDMENT ,
TO ASSEMBLY SUBSTITUTE AMENDMENT (LRBs0096/1),
TO 2011 ASSEMBLY BILL 96

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 1, line 6: before that line insert:

3 **“SECTION 1b.** 15.05 (1) (a) of the statutes is renumbered 15.05 (1) (a) 1. and
4 amended to read:

5 15.05 (1) (a) 1. If a department is under the direction and supervision of a
6 secretary, the secretary shall be nominated by the governor, and with the advice and
7 consent of the senate appointed, to serve at the pleasure of the governor, except as
8 provided in subd. 2.”

9 **SECTION 1g.** 15.05 (1) (a) 2. of the statutes is created to read:

10 15.05 (1) (a) 2. The secretary of veterans affairs shall be nominated by the
11 governor, and with the advice and consent of two-thirds of the senate present and
12 voting, shall be appointed to serve at the pleasure of the governor.”.

2. Page 1, line 6: substitute "**SECTION 11m**" for "**SECTION 11**".

3. Page 1, line 9: after "with" insert "a county veterans service officer from each county in the state and with".

4. Page 3, line 16: after that line insert:

"(2m) Notwithstanding section 15.49 (2) of the statutes, as affected by this act, any person serving as a member of the board of veterans affairs on the effective date of this subsection whose nomination has been confirmed by the senate on or before that date may continue to hold office and exercise the powers and duties of that office for the residue of his or her unexpired term, as determined under SECTION 11 (5), and until his or her successor is appointed and qualified."

5. Page 4, line 3: delete "(a)"

6. Page 4, line 4: delete lines 4 to 20 and substitute "stats., and section 15.49 (2) of the statutes, as affected by this act, the 2 members of the board of veterans affairs who are serving on the board on the effective date of this act and whose terms expire on May 1, 2019, shall serve for terms expiring on May 1, 2017."

7. Page 4, line 20: after that line insert:

SECTION 12. Effective date.

(1) This act takes effect on February 1, 2015."
