



TO ASSEMBLY SUBSTITUTE AMENDMENT (LRBs0096/\(\frac{1}{4}\)), TO 2011 ASSEMBLY BILL 96

1 At the locations indicated, amend the substitute amendment as follows: 2 **1.** Page 1, line 6: before that line insert: 3 **Section 1b.** 15.05 (1) (a) of the statutes is renumbered 15.05 (1) (a) 1. and amended to read: 4 15.05 (1) (a) 1. If a department is under the direction and supervision of a 5 secretary, the secretary shall be nominated by the governor, and with the advice and 6 consent of the senate appointed, to serve at the pleasure of the governor, except as 7 8 provided in subd. 2." **Section 1g.** 15.05 (1) (a) 2. of the statutes is created to read: 9 15.05 (1) (a) 2. The secretary of veterans affairs shall be nominated by the 10

governor, and with the advice and consent of two-thirds of the senate present and

voting, shall be appointed to serve at the pleasure of the governor.".
