1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 3, line 16: after that line insert:

3 “(2m) Notwithstanding section 15.49 (2) of the statutes, as affected by this act,
4 any person serving as a member of the board of veterans affairs on the effective date
5 of this subsection whose nomination has been confirmed by the senate on or before
6 that date may continue to hold office and exercise the powers and duties of that office
7 for the residue of his or her unexpired term, as determined under SECTION 11 (5), and
8 until his or her successor is appointed and qualified.”.

9 **2.** Page 4, line 3: delete “(a)”.

10 **3.** Page 4, line 4: delete lines 4 to 20 and substitute “stats., and section 15.49
11 (2) of the statutes, as affected by this act, the 2 members of the board of veterans
