5 RELATING TO REDISTRICTING CONGRESSIONAL AND LEGISLATIVE DISTRICTS. ✓ All bills for  
6 payment that are submitted to the legislature during the 2011-13 ✓ fiscal biennium  
7 for legal and consulting services relating to the redistricting of congressional and  
8 legislative districts shall be itemized to the greatest extent possible and shall be  
9 posted by the chief clerks of the senate and the assembly on an Internet Web site ✓  
10 maintained by the legislature.” ✓
