ASSEMBLY AMENDMENT ,  
TO 2011 SENATE BILL 150

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 20, line 11: after that line insert:

3 **"SECTION 29m. Nonstatutory provisions.**

4 (1) EXPENDITURE OF LEGAL AND CONSULTING FEES FOR PURPOSES OF REDISTRICTING  
5 CONGRESSIONAL AND LEGISLATIVE DISTRICTS. Not more than \$500,000 may be expended  
6 by the state for legal and consulting fees for the purpose of the redistricting of  
7 congressional and legislative districts."
