3 "SECTION 29m. Nonstatutory provisions.

4 (1) EXPENDITURE OF LEGAL AND CONSULTING FEES FOR PURPOSES OF REDISTRICTING

5 CONGRESSIONAL AND LEGISLATIVE DISTRICTS. No moneys may be expended by the state

6 for legal and consulting ~~fees~~ ^{services relating to} for the purpose of the redistricting of congressional and

7 legislative districts that are performed on or after the effective date of this

8 subsection. All bills for such legal and consulting services performed before the

9 effective date of this subsection shall be submitted ~~to the person performing the~~

10 ~~services~~ before August 1, 2011."
