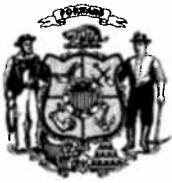

1 At the locations indicated, amend the bill as follows:

2 1. Page 1, line 3: after "state" insert "and deletion of the waiting period for
3 unemployment insurance claimants".

4 2. Page 2, line 1: before that line insert:

5 "SECTION 108.02 (26m) of the statutes, as created by 2011 Wisconsin Act
6 32, is repealed.

7 SECTION 108.04 (3) of the statutes, as created by 2011 Wisconsin Act 32,
8 is repealed."

9 3. Page 2, line 1: delete "SECTION 1" and substitute "SECTION 1e".
